**Conducting Re-examination of 125 Candidates Present on 28<sup>th</sup> May 2017 at Day Care Centre Solutions Nashik Centre.**

CET CELL had conducted MAH-M.Ed. CET- 2017 on 28<sup>th</sup> May 2017 in 20 cities and 22 Venues in Maharashtra successfully.

However, due to Short Circuit and other Technical Failures the CET of the 125 candidates present at Day Care Centre Solutions, Ram Nagar, Old Indira Nagar Police Station, Nashik 422009, could not be completed.
