LL.B-3 Yrs. CAP Form Filling Extension & Editing of PART I

By way of Notices and Schedule/Time Table cited above CET CELL had announced the Centralized Admission Process (CAP) Time Table for Full Time Regular Professional Course leading to Degree LL.B-3 Yrs. and had extended the form filling dates in the interest of the candidates.

CET CELL has taken a stock of the Form Filling Process and has observed as under:-

- i) Out of 27,342 candidates 5,904 candidates have not yet registered for CAP Process
- ii) Out of 21,438 candidates who have filled in PART I of the CAP Form 2,243 Candidates have not yet filled in their PART II of the CAP Form.
- iii) Some Candidates have reported to CET CELL through personal visit, E-mail, Phone that they have filled in the PART I of the CAP Form by filling in Academic Score of V Semester Marks, which is wrong.

Considering above facts and oral instructions received from the Department of Higher and Technical Education LL.B-3 Yrs. CAP Form Filling date is being extended as under:-

CET CELL is making the last opportunity available for unregistered Candidates and the Candidates who have not filled in PART II to register themselves and complete PART I and PART II of the CAP Form.

CET CELL is also making the Editing facility in PART I of the CAP Form available to the candidates who have filled in the wrong details like---

- i) Graduation/Post Graduation Marks
- ii) Gender
- iii) Date of Birth
- iv) Minority Type (Linguistic/ Religious)
- v) Category
- vi) Candidature Type.

If the unregistered candidates do not fill in/Edit the CAP form Part I and Part II within stipulated period mentioned above, and already registered candidate do not edit their PART I of the CAP Application and submit the form on line, CET CELL will go ahead with Admission Process considering the Completed Applications of the Candidates only. The Candidates who do not fill in the PART I and PART II will be left out of the process till the start of the III Round of Allocation.
